## BREATH ALCOHOL TECHNICIAN & TRAIN-THE-TRAINER COURSES

MEDI offers a course of instruction for certification as a Breath Alcohol Technician (BAT) and BAT Train-the-Trainer Certification. Training and certification are specific to one of the following breath alcohol testing instrument models:

**Lifeloc Phoenix 6.0BT**  
**Lifeloc EV30**  
**CMI Intoxilyzer 400**  
**CMI Intoxilyzer 240/240D**

The course offered follows guidelines established by the U.S. Department of Transportation (D.O.T.), Office of Drug Policy and Compliance in their publication, BREATH ALCOHOL TECHNICIAN TRAINING: DOT MODEL COURSE. The purpose of this training is to ensure that persons conducting breath alcohol testing of regulated workers perform services in a consistent and uniform manner. It is apparent that consistency and uniformity are essential during legal proceedings and add confidence in the testing process to persons subject to testing. This course combines both procedural training and device proficiency training. A certificate of course completion documents procedural training and tester proficiency on a specified breath alcohol test instrument.

Breath Alcohol Technician training is completed in one full day. An additional half day of training is required for Train-the-Trainer. A typical day schedule runs from 8:30AM to approximately 5:00PM, with a half an hour break for lunch. These times are suggested as reasonable approximations but may vary depending on specific requirements of the individuals being trained. The training day is concluded when all trainees have satisfactorily completed procedural training, instrument training and the final examination. Satisfactory demonstration of competence includes a passing score (70% or better) on a required final examination. Please note that the training day may be extended beyond a routine or customary quitting time and trainees must be prepared for this possibility. Certification is valid for five years.

Online training options are also available. Please call us for more information about online BAT courses.

### WHAT YOU BRING TO THE COURSE

- One of the BAT instrument models listed above for each two trainees. Note that it is necessary to have two persons assigned to each instrument during the training sessions. If you have an instrument and only one person to be trained, then perhaps you can enlist the participation of someone from another source to join with you.
- At least one standard gas calibration cylinder and regulator for each two trainees, tygon tubing to gas cylinder interface (available from MEDI if you do not have this)
- A sufficient number of paper and mouthpieces to accommodate multiple tests for each trainee. (A trainee may reuse a mouthpiece for some of the training exercises).

### WHAT IS PROVIDED AT THE COURSE AND INCLUDED IN THE COURSE FEE

- Course presentation materials enclosed in a 3-ring binder
- Required examination
- MEDI Certificate of course completion and certification for Continuing Education Units from the California Board of Registered Nursing (if applicable)
- Certification as a BAT from CMI or Lifeloc
- Catered lunch (only courses held in Benicia, CA)

### THE TRAIN-THE-TRAINER COURSE

The Train-the-Trainer course participants will complete the certification program described above along with additional half day of training on the following day. Successful completion of this program qualifies a person to train BAT technicians to

support their own company program. A Train-the-Trainer is only permitted to train their own employees (not allowed to certify employees of any other company). To qualify for this training, the participant's company must be prepared to comply with a training licensing agreement and a proprietary information agreement with CMI or Lifeloc.
